EYES - BURNING IRRITATION:

INGESTION: DO NOT INDUCE VOMITING. WILL CAUSE CHEMICAL PNEUMONIA. CALL PHYSICIAN AT ONCE.

INHALATION: MOVE PERSON TO FRESH AIR. IF UNCONSCIOUS, CONTACT PHYSICIAN.
